PARTICIPATION

Participants must be design students or young professionals, aged between 18 and 35 years.

Only suitable for design and culture passionate.

Members of the judging panel are unable to take part; the same applies to their relatives and to people who have on-going professional relationships with them.

SUBJECT

The contest will consist in designing an outdoor swing.

REQUIREMENTS OF THE PROJECT

The projects must be industrially reproducible. The use of wood and plastic are excluded.

Designs must be original and must not be entered in any other competitions or previously published.

DOCUMENTATION TO BE PRESENTED

A) Complete form with the following information hosted on the GANDIABLASCO's official website, contest section:

- Name, address and telephone number.
- Photocopy of ID card.
- Curriculum Vitae.
- A signed statement that the design submitted is original and has not been entered in any other competitions or previously published.

B) A folder with the identification title on the cover, containing:

- A full description of the project:
 - I. Description of the product and construction details.
 - II. An estimate of the manufacturing costs.
- A3 Panels on a stiff support (minimum of 2 and maximum of 3):
 - I. Contoured plans of the design: layers, elevations and sections.
 - II. Technical details explaining the construction of the product.
 - III. Isometric perspectives, rendered images or photographs.

Projects must be well packaged, with no visible means of identifying entrants, except by the title and the contestant's identification data.
