The participants will give life to the "Zanotta & Cristalplant® Design Contest", a contest that has the additional goal of revealing the still unexpected features of this material.

Participation:

Participation to the contest is free of charge and open to the young designer from any nationality being born after the 1st of January 1970. The participation requires the acceptance of this contest rules and the free of charge assignment/transfer of copyright as for the projects submitted to contest.

Prizes:

A qualified panel will screen and select the best projects, one by each category.

Given that, in compliance with the Italian Presidential Decree n. 430 of the 26th of October 2001, the hereby contest has been exclusively set up for the submission of design projects and it is not intended as a prize contest:

- All the expense related to the engineering, prototyping, moulds, as well as for the first piece produced out of Cristalplant[®] material and assigned to the winner of each category, shall be born by Nicos International, as recognition of personal merit.

As in all contests, the verdict of the jury shall be considered final.

Dimensions and media:

All the projects shall be submitted in technical format .stp and .igs; the renderings shall be submitted in the form of three chosen images in .jpg format and with a 300 dpi resolution, on a CD.

A prototype, preferably in a 1:5 scale, would be appreciated.

A box/envelope without markings, writings, or symbols, shall include:

- 1) A CD containing the project/s with only a slogan and art name on it.
- 2) 1 sealed envelope with the same slogan and art name used on the CD, containing the "Cristalplant® Design Contest" participation form duly filled in all fields as well as the authorization to the use of personal data.
- 3) A printed version (A4 size) portaying the three images and the slogan. Warning: do not indicate name and surname.
- 4) Possibly a prototype in a minimum 1:5 scale, with the same slogan and art name on it as per point 1).

Copyright:

The intellectual property of the submitted projects remains property of the individual designers who, as for the **selected products**, accept by signing the hereby announcement, the free of charge and complete assignment/transfer of copyright as for the projects submitted to contest.

Should the product be included in Zanotta's product catalogue, the relevant rights of sale will undergo specific agreements with Zanotta company, by signing regular contract on professional standards.

Terms and deadline:

By the 12th of March 2010 the projects must be submitted at the following address:
