The written part of the work must be bounded with a separate cover in A4 format and in 2 copies. In order to achieve a complete anonymity of the competing work, the works must be submitted in a closed envelope with the annotation *Public procurement Competition No.04/09* - coded - Do Not Open! The information of the author must be stated separately in a separate closed envelope submitted in the work with the annotation "Author" and marked with the identical code. In another envelope with the annotation "Return Address for the work" coded in the same manner, the address where the work that was not awarded or purchased should be stated. The candidates that apply to the competition must give their consent for disclosure of their identity after the opening of the competing works. The work must be submitted in opaque and sealed envelope protected from damages during the transport.
